

PSYCHOTHERAPY VIA DIGITAL MEDIA

- During the Corona lock down psychological and psychotherapeutic services are done via digital media in Austria
- Different digital media are used: zoom, skype, ... or phone calls
- The health insurances accept the psychotherapeutic treatment via digital media
- It is allowed for psychotherapists/psychologists to use digital media until the end of the year or maybe longer (Covid?): no limits at the moment
- Hotlines for mental health problems (BÖP Helpline,)

DIGITAL HEALTH APPS

- There is some research regarding this topic at university level
- No statistical data
- only a small part of psychotherapists uses digital health apps
- Example: Phobic therapy using virtual reality (www.phobius.at)
- No official guideline for digital health apps in Austria



VIRTUAL REALITY

E-HEALTH

- Online counselling is allowed
- There are guidelines for online counselling in Austria
- Special competence in online counselling is required

SITUATION

- High acceptance for psychotherapy via digital media since Covid-19
- Discussion: benefits/risks?
- Discussion: psychological assessment via digital media?
- Guidelines for psychotherapy via digital media should be developed

HEALTH PROFESSIONS

- 10.256 psychotherapists (regulated 1990)
- 10.972 clinical psychologists (regulated 1990/2013)
(about 1/3 = both qualifications)
- 10.396 health psychologists (regulated 1990/2013)

Regulation: Ministry of Health, Austria

PSYCHOTHERAPY


- Psychotherapy is regulated by law 1990
- A revision of the law is in discussion
- Discussion points:
 - education at academic level (bachelor, master, additional training) ?
 - Difficulties to establish the education on public universities (now education is on private level)
 - 24 methods (related to 4 clusters)
 - Actual access to education: social/health/....professions or “special access“ (Eignung)

PSYCHOTHERAPY

- Psychotherapists are not allowed to prescribe medications or other treatment (only refer or recommend other treatment)
- Corona changed the situation:
 - Psychotherapy via digital media is allowed
 - High acceptance

EDUCATION IN PSYCHOTHERAPY

- Access: social, health, ... profession or special access
- General part (Propädeutikum): 1.315 hours
- Specific part (Fachspezifikum): minimum 1.800 hours
- Duration: 3 to 6 years
- Different education associations (private level): 39
